School Activities Guidelines:

1. Students are expected to follow the same rules and guidelines that are observed during regular school day (consequences will apply to after school activities the same way as during a regular school day).
2. Students must be in regular school attendance the day of the activity in order to participate that day.
3. Attendance will be taken at the beginning of each session - students are expected to report to their activity on time. Students signed up for an activity may not go outside after school to visit with their friends.
4. Parent(s) may be contacted if his / her student fails to attend a session without a pre-excused note or phone call from the parent.
5. Lack of attendance, motivation, or disruptions to others may result in a student being dropped from the activity.
6. No refunds or changing of activities after: _____.
7. Misbehavior while riding an activity bus may result in loss of bus privilege; which may result in the student being dropped from the activity he / she has signed up for.
8. All school and bus rules must be followed.

If a student is not riding an activity bus home, his / her parent must be available to pick their student up no later than 5:00pm. No student supervision is available after 5:05pm and therefore, students not riding an after school activity bus home must be picked up by 5:00pm or may be dropped from their activity. No refunds will be issued.
